## **Pistol Permit Application Guidelines**

- Please bring the required items with you when submitting your pistol permit application:
  - 1) Completed & signed pistol permit application
  - 2) Valid, government issued photo ID
  - 3) Permit fee
- Pistol permits are issued in yearly increments, up to 5 years. The fee is \$15.00/year.
  - o 1-year permit fee: \$15.00
  - o 2-year permit fee: \$30.00
  - o 3-year permit fee: \$45.00
  - o 4-year permit fee: \$60.00
  - o 5-year permit fee: \$75.00
- Pistol permit fees must be paid with cash, check, or money order. No other forms of payment are accepted at this time.
- Permit applications are accepted 24 hours a day, 365 days a year.
  - o Monday – Friday (8:00 a.m. – 5:00 p.m.): Applications accepted at front desk.
  - o After hours & holidays: Applications accepted at Dispatch Entrance on the west side of the building.
- Pistol permit applications will be accepted via standard mail. DO NOT mail money with your application. Once a signed and completed application is received, the Limestone County Sheriff's Office will perform the required background check and notify the applicant via phone of their application status. However, the permit must be signed in person. Applicants must appear in person at the Limestone County Sheriff's Office to pay the permit fee and pick up the pistol permit.
